Your Will, your wishes

Your Will is a unique and clear record of the way in which you want your possessions, property and money (your estate) to be distributed when you die.

A signed, correctly worded Will brings peace of mind as you know that you have remembered your loved ones, as well as the charities you choose to support after your death.

As a Will is a legal document, we strongly recommend you seek professional assistance from a solicitor or a trustee company, to ensure that your wishes are clearly and correctly recorded.

There are a variety of options available to you. Your gift can be:

- **Residuary** – the remainder of your estate after provisions for family and other beneficiaries have been settled
- **Percentage** – of the value of your estate
- **Pecuniary** – a specific sum of money
- **Specified Bequest** – a particular item, such as a vehicle or a house.

You have a choice of where you would like your bequest to be allocated:

- Gifts left to Mercy Hospice are allocated to the hospice's operational budget and are used to fund patient care and large capital projects.
- Gifts left to Mercy Hospice Foundation are invested in perpetuity, providing financial sustainability and security for the care of patients in the future. Every year interest from this fund contributes directly towards our palliative care services.

Suggested wording for your Will:

"I give to Mercy Hospice, 61 College Hill, Ponsonby, Auckland the sum of \$..... or (percentage of my estate, or the remainder of my estate, or a description of assets or property) for the general purpose of patient care, for which the receipt of the Chief Executive or other proper officer shall be full and sufficient discharge to my trustees."
