## **Terms & Conditions**

By purchasing your ticket to '10 – A Celebration of Tastes' ("the Event") you agree to all terms and conditions set out by the Event organiser, Mercy Hospice:

- 1. '10 A Celebration of Tastes' is organised and promoted by Mercy Hospice with the main purpose of raising funds for the organisation's work.
- 2. '10 A Celebration of Tastes' is a community event and as such it is expected that entrants will conduct themselves in a manner that reflects well upon themselves, Mercy Hospice and the Event. It is expected that participants show respect towards all Event officials, other participants, and members of the general public. Mercy Hospice reserves the right to withdraw an individual from the Event if, in their sole opinion, the individual is not adhering to the terms and conditions or a reasonable request from Mercy Hospice, the Tennis Clubs, or a Mercy Hospice representative.
- 3. All participants must comply with Covid-19 requirements to attend an event, as mandated by the New Zealand government at the time of the event.
- 4. Participants must be aged 18 years or older.
- 5. Should the event be cancelled, participants will have the following options:
  - a. If cancellation occurs prior to **May 6, 2022**, the ticket fee can either be fully refunded or donated to Mercy Hospice (making the donation eligible for a 33% tax credit for New Zealand resident taxpayers).
  - b. If cancellation occurs after May 6, 2022, the ticket fee can be donated to Mercy Hospice (making the donation eligible for a 33% tax credit for New Zealand resident taxpayers) or partially refunded up to 85%. The remaining 15% of the ticket fee covers costs Mercy Hospice has incurred in relation to the Event.
  - c. If your ability to participate in the Event is affected by changing Government guidelines and/or requirements in relation to Covid-19 – including, but not limited to, restrictions due to vaccination certificates, localised lockdowns, travel restrictions or similar – then the options outlined in clauses 5a and 5b apply, subject to date.
- 6. In the event of postponement, all tickets will be transferred to the new date, without the need for participants to do anything. If a participant cannot make the new date, they have the option to request a full refund, donate their ticket fee to Mercy Hospice or donate an amount of their ticket and request a partial refund.
- Images, and video taken on the day of the Event may be used by Mercy Hospice in future promotions. If you do not want your image taken, please contact getinvolved@mh.org.nz prior to the Event.

## Coronavirus

- 8. In relation to Covid-19 or any other coronavirus, participants must agree to:
  - a. Respect the advice and instructions you have been given
  - b. Do not go to the Event in the case of suspected Covid-19 symptoms, or in case of contact with a person carrying Covid-19. If necessary, consult a doctor.

- c. Pay particular attention to your state of health, especially if you are a person known as "at risk".
- d. Provide the necessary individual equipment, for example masks and anti-bacterial hand gel, to protect yourself and others.
- 9. You will not be allowed to participate in the Event if:
  - a. You are feeling unwell;
  - b. You are experiencing or showing symptoms of cold, influenza or coronavirus infection including Covid-19;
  - c. You have been directed by a medical professional to, or are legally required to, selfisolate or quarantine at the time of the Event, as applicable, including but not limited to where you are identified as a close contact of someone who has Covid-19.
- 10. You also agree to notify Mercy Hospice immediately if you develop any symptoms of Covid-19 within 7 days of attending the Event.
